- Assignment as an umpire or UIC to a minimum of six (6) Missouri ASA/USA Softball Missouri state championships.
- Assignment as an umpire or UIC to two or more events at the regional level or above, including one ASA/USA national championship. Regional events include National Qualifiers and Hall of Fame Qualifiers
- Involvement with USA Softball-affiliated organizations may be considered to reach these requirements.
- Demonstrated support of umpire training programs at the local or state level.
